Fees Instructions

- Line 25 <u>Percentage Fee Due on Amount Entered on Line 24</u> Percentage fee due equals .3% of the first \$150,000 of taxable revenue entered on Line 24, plus .4% of the next \$250,000 of taxable revenue entered on Line 24, plus .55% of the taxable revenue entered on Line 24 exceeding \$400,000.
- Line 26 <u>Delinquent Fees Due</u> Delinquent fees are due if not officially postmarked by the 1st day of the 2nd month of the calendar quarter. Penalty is \$50 or 25% of Line 25, whichever is greater. However, if less than 10 days late penalty cannot be more than \$1000 and if more than 10 days late the penalty cannot be more than \$5000.
- Line 27 <u>Advance License Fee Payment</u> Advance license fee payment, in an amount identical to the percentage fee due on Line 25, applies only to new licenses having completed their first full calendar quarter year of operation.
