When Animal Protection Services received a call from Henderson Police about a home in Clark County that had no power, and believed to have multiple dogs inside, it was considered a higher priority. The Henderson Police officer who reported this, further advised that the owners of the property were living in tents outside. When the Animal Control officer arrived, she could hear multiple dogs on both sides of the house, as well as, multiple dogs inside of the house. There was a hand painted sign on the property wall and gate that said "dogs will bite". A failed attempt to make contact with the owner resulted in a notice being left to contact CCAPS within 24 hours. Because of the horrific living conditions witnessed by the ACO, the property was reported to Code Enforcement. Upon inspection by Code Enforcement, it was observed that there were inoperable vehicles, solid waste including household junk, and garbage in the front yard. Based on the extreme violations, it was considered a health issue, attractive to rats and vermin. A Notice of Violation was issued. Animal Protection Services returned to the property to meet with the owner and could see that the animals were being neglected and that the environment was not safe or sanitary. Due to the conditions and the property owner stating she was unable to care for all of the dogs, two were surrendered and a citation for deprivation of water was issued. The owner stated that she would tend to the rest of the dogs and would ensure that they all had water. Upon arrival the next day to check on the welfare of the animals, the owner that cooperated the previous day was unavailable and the officer was told to come back at another time. A notice was left to make immediate contact again. When the Officer went back again the following day, it was observed that the dogs were now being placed in a large dog run, provided with a large bucket of water, and the yard was cleared of any major animal concerns. A positive end for Animal Protections Services. Code Enforcement has been a different issue. After the Notice of Violation was issued, a follow up inspection was made 30 days later. The inoperable vehicles remained, most of the solid waste had been removed but the question of restoring

power to the home had not been resolved. A Final Notice of Violation was issued and fees were applied. After another 30 days to get the property into compliance, the violations remained the same, thus an Administrative Citation was issued. To date, power has not been restored and the yard is not entirely in compliance. Code Enforcement is actively

SAVE THE SNAKES

When a landlord has to evict a tenant, it is not easy for either party. Although Nevada law requires a thirty day notice to the tenant, followed by a second five-day notice to quit, this still may not be enough time for the tenant to get all of their belongings before it is considered unlawful to be at the home. Unfortunately that is just what happened in this case. On April 4, 2023, Clark County Animal Protection Services received a call from a landlord stating that his previous tenant had left behind three snakes. When the officer arrived, the landlord brought the officer into the house where she found three snakes in plastic containers, in pressboard shelves. The first two containers that the officer looked in were marked as male and female, both had dried feces, dried paper towel material stained yellow and neither had any water. Both snakes were yellow and severely malnourished, with their spines visible. The third container held a larger brown snake, that had cleaner paper towel material but sill no water. The spine on this snake was also visible. All three snakes were impounded and brought to the Animal Foundation. The two yellow snakes were transferred to Best Friends Animal Society Rescue for care and the larger brown snake was adopted.



Snakes require spectrum lighting, specific temperatures and humidity levels, precise diets and feeding schedules and lots of space. It can be a very difficult task to properly take care of a snake.

And don't forget snakes should be kept in an ESCAPE PROOF cage.

HOO HOO WILL SAVE ME?



Clark County Animal Protections services will save you little owl. CCAPS received a call on April 13, 2023, that there was an injured owl in the tire well of a black jeep parked in a Walmart parking lot. The person reporting believed the owl to be



injured because it was making a lot of hissing noises. Luckily the owl was just afraid with all of the people gathering around and was not injured. The owl just seemed to be lost and trying to find a place to hide. The animal Control Officer was able to safely capture the owl and relocate it to Wetlands Park. Great job Office Narro!

Fun fact about owls. Owls Can rotate their necks 270 degrees. A blood-pooling system collects blood to power their brains and eyes when neck movement cuts off circulation.

EVACUATION DRILL TRAINING

On April 13, 2023, the Horses4Heroes Family Equestrian Center in Lone Mountain held an evacuation drill training. They invited North Las Vegas Fire Department, Clark County Animal Protection Services, and Desert Pines Equine Medical Center to their 2.14-acre property. The objective of the training was to expose the first responders to the layout of the property and the different types of animals housed at the location. Fire safety is a major focus on small farms. The presence of large animals like horses and bulls create an additional safety concern for the first responders and the public. Horses4Heroes staff walked the attendees through the facility and pointed out potential hazards, exit points, and on-site animal handling equipment. Attendees were shown the process of loading and herding animals. The training was beneficial for all involved. It exposed fire responders to the large number of animals they may one day have to rescue.

TIS THE SEASON FOR GREEN POOLS

The season for green pools is among us! What this means for Code Enforcement is that when a complaint is received, they are responding within 24 hours and the pool is drained within 72 hours. Green pools are a priority but can be difficult for Code Enforcement to verify without a legal vantage point.

Code Enforcement considers green pool complaints as imminent dangers to help stop the spread of viruses transmitted by mosquitos.



On April 13, 2023, a complaint of a green pool was received, but when the officer arrived to inspect, it was obvious that the home was vacant. The officer was able to meet with the neighbor who granted the access needed to be able to verify the complaint. This larger than average pool was drained for \$450.00 and a lien was placed on the home.

DILAPIDATED MOBILE HOME













Code Enforcement, accompanied by NEAC COP inspected a manufactured mobile home with severe fire damage . The officer also observed solid waste and debris throughout the structure. Because of the severity of the fire damage, it was deemed unsafe to secure by board up. The property was immediately red tagged as unsafe and a Notice of Violation was sent to the owner. The owner failed to respond in a timely manner, leaving Code Enforcement no option but to post the property with a Notice of Abatement and move forward with obtaining an asbestos warrant. The asbestos report stated there was no asbestos in the structure and that the abatement could proceed. This property was demolished, secured with a surrounding fence and posted for no trespassing. On June 29, 2023, a lien in the amount of \$11,068 was placed on the property.













KYLE CANYON ABATEMENT

It all began in April of 2021, when Code Enforcement received a complaint for multiple junk vehicles and a shed that had been converted to a living space. Upon inspection, the property owner stated he is working on the property every day but that he goes back to town each night to sleep and that the shed had not been converted to a living space. After confirming the shed had not been converted, a Notice of Violation was issued for trash, debris, outside storage, too many recreational vehicles, too many commercial vehicles and an unpermitted structure on property. Giving the property owner due time to correct the violations and failing to do so, a Administrative citation was issued. The Officer continued to work with and provide time for the owner to get the property cleaned but when very little progress was made within six months, a second Administrative citation was issued. Thirty days later, still no progress, a warning to have the property abated was given. The warning seemed to kick things into action for the property owner. Upon reinspection, the inoperable vehicles had been reduced to eight, which is allowed under Clark County Auto Hobby code. Some trash and debris remained but the larger concern at this point was the rolls of artificial grass that covered the 2.72 acres. Unfortunately, the action was short lived and a Notice of Abatement was issued. The property owner appealed the Notice of Abatement and during the hearing the Hearing officer held the owner to have 90 days to correct all violations and to begin the permit process for the structure. The property owner began the permit application process but failed to follow through within the 90 days that was granted. This property was abated, removing 100,000 square feet of artificial turf, a limousine, a van, a Super Duty F-550, a recreational vehicle, a Bobcat

tractor, a forklift, a Fiat, a Jaguar and miscellaneous solid waste. A lien on the property was placed in the amount of \$48,875.00.
