### Water System Update:

This month staff will perform the 1000 zone motor control center replacement, maintenance on water pumps, rehabilitation of the ozone destruct system, and will clean the system's ponds / lagoons.

The Big Bend Water District storage project remains on the State Revolving Fund Loan priority list. The Senate and House of Representatives conference committee process begins for the Water Resources Development Act (WRDA) funding.

The Laughlin Water Reclamation Facility treated an average of 1.62 MGD, producing clean water returned to the Colorado River. Flow decreased by 80,000 gallons per day from this time last year.
