Four OUI arrest Seventy-two citations were issued and countless warnings. One fatal vessel incident that BHPD responded to. Provided water security for five fireworks shows. Four wardens working the W.O.N. Fishing tournament. Expecting 250 boats, 500 anglers on the lake. It's very important to maintain conservation of wildlife. The Laughlin Water Reclamation Facility treated an average of 1.70 MGD, producing clean water returned to the Colorado River. Flow decreased by 40,000 gallons per day from this time last year.

Jason Bailey provided information to the recent questions regarding the cost estimates of the 2-milliongallon reservoir storage tank. The Las Vegas Valley Water District (LVVWD) Engineers have evaluated and estimated the total engineering design and construction cost for a two-million-gallon storage tank to be just under 12 million dollars. This is an all-in estimate which includes engineering, design, permitting and construction cost for the tank. This also includes anticipated cost, including the contractor's mobilization from Las Vegas, the cost to lease land for staging, the cost of precuring and construction the welded steel, pre-stress concrete tank, coating the tank, water quality mixture, electrical control, SCADA programming, inlet - outlet valves and other related equipment.

Jason Bailey said they are aware a 2-million-gallon steel tank can be purchases for 2-3 million dollars, but prefabricated tanks may not meet the requirements, specifications, or criteria for municipal public water system.

As we work with Laughlin and local developers to identify funding opportunities, it's critical that the estimates are conservative enough to reflect the total engineering, design, and construction cost. If inadequate funds were secured it could delay or derail the entire project.

As local developers expand the water system to accommodate new water demands based on their projects, it makes sense they also fund the water system expansion. As a result, the LVVWD will enter into project funding agreement to create opportunities for developers to cost share. This approach allows systematic water expansions without impacting residents and their rates.

We will continue to look for funding opportunities which may include Federal, State, local grants such as the USDA.

Water System Update:

Staff are continuing Supervisory Control and Data Acquisition (SCADA) upgrades.

The Big Bend Water District (BBWD) storage project was not selected to receive Nevada Water Conservation Infrastructure initiative grant funding. The BBWD storage project remains in the State Revolving Fund Loan priority list, and management and staff continue to seek additional external funding sources which may include federal state and local grants such as the US Department of Agriculture and the Army Corps of Engineers.
