Water System Update:

Staff are prepping for continued supervisory control and Data Acquisition (SCADA) upgrades, the new installation of a new Chemical feed pump to improve treatment process redundancy, and the replacement actuators for filters.

Staff applied for the Nevada Department of Conservation and Natural Resources for American Rescue Plan Act (ARPA) funding for the Big Bend Storage Project in the amount of \$12 million for the first of two storage tanks (2MG tank expansion at the existing 750 Zone Tank Site). A decision on funding is anticipated this month.


