Statistics August 2024:

Captain Quintela provided information on the large brush fire that burned 63 acres. All agencies came together including a helicopter and had the fire under control in a quick timely manner. No structures were damaged.

Diversions: August 2024, 314 - acre feet. 2024 Total diversions: 1,990 acre-feet

Water System Update:

Cleaning and servicing the river intake screens to help prevent clogging and restriction to the treatment facility, replacement chemicals feed pumps for treatment and distribution system have been ordered.

The Big Bend Water District storage project remains on the State Revolving Fund Loan priority list. Staff submitted information and support letters for Water Resources Development Act (WRDA) funding to seek additional external funding sources.

Kathy Ochs inquired about her request for 2008 documents. Jason Bailey said he is working with Clark County administration records to find the files in their archive.

5. Receive a report from Will Smith with Clark County Water Reclamation District regarding the status of the wastewater system. (For discussion only)

The Laughlin Water Reclamation Facility treated an average of 1.78 MGD, producing clean water returned to the Colorado River. Flow decreased by 20,000 gallons per day from this time last year.

There was a long discussion that included funding options and the time frames. NBD (Nevada by Design) – WESA (World Economic Support Agency offers a range of services that include business development services, infrastructure projects, workforce development, tourism, and marketing to name a few.

Kathy Ochs motioned to approve a support letter for NBD. Motion approved by a voice vote 5-0.

2. Reconsider issuing a letter of support to the Board of Clark County Commissioners supporting a loan from the Fort Mohave Development Fund to the Big Bend Water District for the construction of a water storage tank, per LTAB direction at the August 27, 2024, meeting. (For possible action)

There was a long discussion that included Doa Ross from the Las Vegas Valley Water District (LVVWD) who provided additional information and reiterated her discussion from last months TAB meeting and answered questions.

Carrie Larson spoke regarding the cost and provided handouts with what the cost should be according to her, and said the estimates provided by the LVVWD was twice what it should be. Robert Bilbray does not support using FMDF to help fund the new water storage tank.

Kathy Ochs Motioned to table this item until further notice. Motioned passed by a voice vote 5-0.
