### CONDITIONS OF APPROVAL Current Planning

• 1 year to review as a public hearing;

• The proposed heliport is for private use only and not to be used for any commercial activities.

• Applicant is advised that the County is currently rewriting Title 30 and future land use applications, including applications for extensions of time, will be reviewed for conformance with the regulations in place at the time of application; a substantial changein circumstances or regulations may warrant denial or added conditions to an extension of time and application for review; the extension of time may be denied if the project has not commenced or there has been no substantial work towards completion within the time specified; and that this application must commence within 2 years of approval date or it will expire.

# **DEPARTMENT OF AVIATION**

• Applicant may be required to file Federal Aviation Administration (FAA) Form 7480-1,"Notice of Landing Area Proposal" with the FAA, per 14 CFR Part 157;

• Applicant must comply with all heliport planning report requirements described in Table 30.44-1 "Heliport" of the Code.

• Applicant is advised that all helicopter noise complaints and inquiries regarding operations from this facility will be forwarded to the operator of this heliport.

# CLARK COUNTY WATER RECLAMATION DISTRICT (CCWRD)

• Applicant is advised that there are no public sanitary sewer facilities available within the proposed development and none are planned within the next 5 years.
