  - 1. Nevada Department of Transportation (NDOT) to discuss the purpose of the installation of Traffic Flow Cameras as part of the Freeway & Arterial System of Transportation (FAST) Package H3 Project. (for discussion only)

Denise Inda and Mike Yates from the Department of Transportation – The FAST Package H3 Project combines message signs, cameras and flow censors which provides information related to

road conditions and hazards. This allows NHP, Metro, RTC and NDOT the ability to view live feed in order to redirect traffic, respond the hazards and relay information to travelers. This live feed is available to anyone <u>https://nvroads.com/</u>; although, the two new cameras are not currently accessible due to them being in the installation/testing stage. The cameras do not record and cannot be used for enforcement purposes. There are two new cameras: one located on the Riverside Road/I70 at the Bunkerville bridge and the other located in Mesquite, near exit 120.

2. Members of the U.S. Census Bureau in Nevada to discuss the 2020 Census process and provide information on available job opportunities (for discussion only)

The 2020 Census is required under and constitution and is a major deciding factor in how a community receives its funding such as education, infrastructure, rental assistance, emergency funding, market research and many other community benefits. All information is protected by law and can only be used for statistical purposes; NOT shared amongst any other government or private agencies.
