Resolution

RESOLUTION ADOPTING THE LAS VEGAS VALLEY WATER DISTRICT COMMUNITY SOURCE WATER PROTECTION PLAN FOR THE SEARCHLIGHT PUBLIC WATER SYSTEM, SEARCHLIGHT, NEVADA

WHEREAS, the Las Vegas Valley Water District (District) operates and maintains the Searchlight public water system; and

WHEREAS, the Searchlight Town Advisory Board (TAB), pursuant to NRS 269.576 and County Code, Chapter 3.30, is to assist the Board of County Commissioners in governing the unincorporated town of Searchlight by acting as a liaison between the residents of the town and the Board of County Commissioners and to advise the Board of County Commissioners on matters of importance to the unincorporated town and its residents; and

WHEREAS, the District has developed a Community Source Water Protection Plan (CSWPP) in cooperation with the Nevada Division of Environmental Protection (NDEP) and other public agencies to inform the community of Searchlight, Nevada, of their drinking water resources and provide guidelines that enable them to protect their drinking water supply by making informed planning decisions in concert with the District and Clark County; and

WHEREAS, the Searchlight TAB serves as a member of the Searchlight CSWPP local planning team, representing the residents of Searchlight which utilize the Searchlight public water system; and

WHEREAS, the Searchlight TAB received a presentation and a written copy of the Searchlight CSWPP on October 9, 2024, and was invited to provide comments through November 13, 2024; and

WHEREAS, adoption of the Searchlight CSWPP is a prerequisite to the State of Nevada's endorsement of the 2024 CSWPP and improves the District's ability to secure grants to implement various projects related to source water protection; and

WHEREAS, the Searchlight TAB finds that it is in the best interest of the Searchlight community to adopt the 2024 Searchlight CSWPP to guide activities concerning the protection of Searchlight's drinking water sources; and

NOW, THEREFORE, BE IT RESOLVED, the Searchlight TAB supports the Searchlight CSWPP compiled by the District dated November 2024 and endorses its adoption and implementation.

The foregoing Resolution was passed and adopted on the 11th day of December 2024.
