#### V. Informational Items

Wayne Mesenbrink, Commander, VFW Post 10468, presented an award to Susan Landseadel on behalf of the VFW, the Searchlight Volunteer Fire Department, and the Searchlight Betterment Organization. Commander Mesenbrink stated that Susan is our "EMT and our angel" and read a statement thanking Susan for exemplary humanitarian efforts both on and off duty and for giving above and beyond the call of duty as an EMT. On behalf of the VFW, Susan was awarded a check for \$250 and Joan Mesenbrink from the Searchlight Senior Center presented Susan with a bouquet of flowers.

2. Receive a report from Metro Police regarding activity and statistics during the past month and other area crime concerns. (For discussion only)

Audrey Morrison expressed her thanks for the extra attention Metro Police has given to speeding on Highway 95. Officer Maloney acknowledged that an extra patrol has been sent up specifically for the purpose of traffic control on Fridays. He also stated that they plan to send up extra patrols on Cottonwood Cove Road when the warmer weather starts.

Chair Myers also thanked Metro Police for their professionalism and for providing a fast response time in handling an issue he encountered recently. Officer Maloney replied that the decrease in response time is also due to the fact that more patrols have been assigned to the area.

Tony Chavira stated he thought the police were local. Officer Maloney explained that Metro Police are not permanent in the area but are shared between Laughlin, Searchlight, and Nelson's Landing.

2. Receive a report from Nevada Highway Patrol regarding activity and statistics during the last month and other public safety concerns. (For discussion only)

4. Receive a report from Gabby Villafuerte with Las Vegas Valley Water District regarding the status of the water system. (For discussion only)

Derek Jackson provided the January report.

January 2020 Searchlight used 4.14 million gallons of water. January 2019 Searchlight used 5 million gallons of water.

The community of Searchlight used almost 900,000 gallons less in January 2020 than it did in January of 2019. This continues a declining trend in water use which is attributed to finding pipelines that were habitually leaking and getting them repaired or replaced.

"We are working on some additional pipeline replacements and upgrades for the Searchlight water system. We are looking to replace the 4" PVC main, which has had several breaks on Orlando Street, and replace and upgrade the 2" main on Desert Sage to 6" PVC with a new hydrant installed at the corner of Orlando and Desert Sage. We are also looking to replace the 2" main that is on Water Spout Street. between Colorado and Montana Street. This line has had several breaks over the last few years. We hope to have these done by the end of March or beginning of April," he said.

These projects will be funded mostly by Army Corps of Engineers funds with the remainder covered by system funds.

- 8. Receive a report from Kelli Carlson with Searchlight Library regarding current and upcoming programs. (For discussion only)
  - 1. Children's Activities:
    - a) Tuesdays and Wednesdays after school are snacks and open play.

- b) Educational and craft programs will be held on Thursdays after school. 4-H will be held on February 12<sup>th</sup> and 26<sup>th</sup> with a Lego robotics unit and a Cubelets robotics program on the 20<sup>th</sup>. The Library's brand new Cubelets sets represent a \$4,000 investment in the Searchlight branch by the Clark County Library District. A St. Patrick's Day craft program will be scheduled early next month.
- c) There are nine entries for the Library's Winter Reading Challenge for K-12 kids, which is the highest participation in 2 <sup>1</sup>/<sub>2</sub> years. Twenty-five dollar Amazon gift card prizes will be handed out this week.
- d) 4-H for older kids will hold an advanced robotics unit after the grade school group on February 12<sup>th</sup> and 26<sup>th</sup>.

  - e) Budgeting is happening so the Library is gathering statistics with which to justify its existence. Statistics were provided that spanned the last 2 ½ years in order to thank the public for their support of the Library. Attendance and food distribution on the youth side is up 525 percent from fiscal year 2016-17, adult programming attendance is up 285 percent and door count is up 275 percent. Ms. Kostecky indicated that the Nook had new things placed in it every week and invited the public to come and enjoy it.

Audrey Morrison announced that the Senior Center has donated a ping pong table to the Community Center for anyone who wants to organize tournaments. Contact Michele Brown to get set up.

10. Receive a report from Kyle Myers regarding current road conditions and Public Works concerns. (For discussion only)

Tony Chivara reported that 4-5 heavily weighted semi-trucks are going up Encinitas Street coming from the rock quarry. He stated that it is lucky that the weather is cool currently or the street would be damaged. Chair Myers said he did not think it would pertain to Public Works but he would call around to see what information he could get on the matter.

11. Announcements of upcoming neighborhood meetings and County or community meetings and events. (For discussion only)

Dr. Brian Paulson, Clark County liaison for Searchlight, announced the following updates:

- a) Clark County Administrative Services has placed an ad in Sunday's *Las Vegas Review-Journal* announcing they will be taking applications to fill the vacant position on the Searchlight Town Advisory Board. The appointment will be for the remainder of the current term ending January 4, 2021. Applicants must be eligible to vote and live within town boundaries. A flyer with details is available on the information table at the back of the room.
- b) The Laughlin Town Manager's Office is also looking to fill a vacancy. Applications for a part-time clerical assistant with a wage of \$9.00 per hour for 19<sup>1</sup>/<sub>2</sub> hours per week.
- c) There are two weeks remaining for anyone who would like to apply for U.S. Census work covering Searchlight, Cal-Nev-Ari, and Palm Gardens.
- d) Information on any of the above is available at the Laughlin Town Manager's Office at (702) 298-0828.

Mark Robledo, Clark County Management Analyst for the Laughlin Town Manager's Office, presented an update from the meeting at the Searchlight Senior Center with Commissioner Michael Naft. He stated that Commissioner Naft wanted to thank everyone who came and that there was a very good turnout of about 40 people. Mr. Robledo had received answers to some of the questions that were asked at that meeting which he then provided:

a) The roof repair was completed on January  $22^{nd}$ .

- b) The back door and ceiling tiles installations were both completed on February 6<sup>th</sup>.
- c) The exterior painting of the Senior Center and the Community Center is scheduled for late March.
- d) The flooring for the Senior Center is funded but they haven't gotten an estimate yet. The start date is projected for 2-3 months from now.
- e) The parking lot will be crack sealed and restriped approximately 9-12 months from now.
- f) The parking lot at the Community Center is scheduled to be repaired/replaced this coming summer. An exact month was not provided.

Janis Kostecky announced that the Senior Center board meeting will be Thursday, February 13<sup>th</sup>, at 3:00 p.m. and anyone who wished to attend is welcome.

Michele Brown with Clark County Parks and Recreation announced that the Democratic Caucus will be held at the Searchlight Community Center on Saturday, February 22<sup>nd</sup>. Caucus volunteers will arrive at 7:30 a.m., open up at 9:00 a.m., and close at 4:00 p.m.

12. Discuss amending Title 30.44 in regards to large livestock in residential areas. (For discussion only)

Diane Kendall requested that this item be put on the agenda for next month for action. She proposed that Title 30.44 be amended to take Searchlight out of being labeled an agricultural community and take large livestock out of Searchlight unless on the outskirts by two acres or more.

Chair Myers brought up the point that Title 30.44 applies to a number of locations besides Searchlight. Ms. Kendall replied that she is not suggesting that other areas be considered, only Searchlight since "we are not agricultural."

An unnamed person in the audience asked if instead we couldn't request that Searchlight be made to come under a different zoning other than R-T (Rural Transition).

Ms. Kendall replied that this would be a question for Clark County. She had requested they be present for this TAB meeting and would like them to be present for the upcoming one so that we can get information and direction.

Chair Myers asked if Ms. Kendall thought that recommending an ordinance from the Clark County Board of Commissioners would make the process simpler than amending Title 30.44 as a whole.

Ms. Kendall responded that she didn't know and would need to ask Clark County for guidance. She would like it to be an item for action on the next agenda.

Chair Myers stated the Board would take that into consideration.

VI. Planning & Zoning:

#### 1. UC-19-0809-DOING RILEY GENTRY:

**USE PERMITS** for the following: 1) to allow agriculture livestock, large (horses) and agriculture livestock, small (chickens) prior to a principal use; 2) allow an increase in the number of agriculture livestock large (horses); and 3) allow accessory agricultural buildings prior to a principal use.

**WAIVERS OF DEVELOPMENT STANDARDS** for the following: 1) fence height; and 2) fence setback on 0.2 acres in an R-T (Manufactured Home Residential) zone. Generally located on the south side of Encinitas Street and the west side of Lincoln Street within Searchlight.

Chair Myers asked for a show of hands from those who would like to change the time to 6:00 p.m. A large majority responded by raised hands.

Chair Myers moved that the time for Searchlight TAB meetings be changed to 6:00 p.m.
