2. Public Comment

3. Approve Meeting Minutes from October 22, 2018 (For Possible Action)

4. Discuss and Approve the Addition and/or Removal of Items from the Tracking List (For Possible Action)

- **A.** Addition:
 - i. The committee motioned to add a tracking list item, "Add supplementary language to the Lands Bill regarding OHV use", this has been added to the Tracking List (Tracking Item #18) with Michael Frye as the Issue Manager.

B. Tabled:

- i. The committee motioned to table the Las Vegas Valley Loop Trail (Tracking List Item #12) because of the conflict of interest posed.
- ii. The committee motioned to table the Rooftop Solar Legislation (Tracking List Item #17) because of the underwhelming feedback from Legislators.

The committee motioned to combine Tracking List Item 10 "Add County Designated Roads/Trails to the Federal Legislation" and Tracking List Item 14 "Clark County Trails System" to Tracking List Item 4, "Identification & Prioritization of Race Tracks/Courses)".

- A. Designation of Logandale Trails in Federal Lands Bill (Tracking List Item #3)
- **B.** Add County Designated Roads/Trails to the Federal Legislation, Clark County Trails System, and Identification & Prioritization of Race Tracks/Courses (Tracking List #4)
- C. HR 857 Off Road Recreation & Conservation Act (Tracking List #5)

The rest of the Tracking List Items will be "low" priority.

6. Provide Update(s) on Issues on the Tracking List (For Possible Action)

A. HR 857 (Tracking List Item #5)

Ms. Henson met with David Lamfrum, National Parks Conservation Association (NPCA), who said that the Desert Tortoise Conservation Center has been in the bill since inception and was included in legislation by Senator Feinstein to deal with the closing of the Desert Tortoise Conservation Center in Las Vegas. The NPCA realizes the importance of designating OHV areas to balance the need for recreation as well as the protection and creation of national parks. The window of opportunity to amend HR 857 is closed, however, Clark County can still pursue a bill similar to HR 857.
