Clark County Government Center

The May 16, 2009, Desert Conservation Program (DCP) Multiple Species Habitat Conservation Plan (MSHCP) Permit Amendment Community Advisory Committee (CAC) meeting consisted of a field trip organized by the Clark County DCP to familiarize the committee members with some of the locations and issues associated with the MSHCP permit amendment process. The field trip began at the Clark County Government Center where participants signed the attendance sheet and were briefed prior to departing on the tour. The tour departed at 8:20 a.m.

The committee's first stop was the El Dorado Energy Solar Plant. En-route, the group picked up Brok Armantrout, Boulder City, and Bob Oliver, Boulder City Conservation Easement (BCCE) Law Enforcement Officer. Brok briefed the committee on the history, operation, size and future plans for the solar plant. The tour arrived at the plant at approximately 9:10 a.m., and the committee members disembarked to view the plant.

At about 9:20 a.m., the committee members got back on the bus and and the tour headed for the race course staging area. Brok answered questions about the solar energy plant and geothermal exploration.

Following the questions, John Tennert, DCP Permit Amendment Project Manager, discussed renewable energy projects and the amount of take those projects involve. Following John's coments, Bob Oliver spoke on the history of the illegal race course.



During Bob's remarks a tortoise was spotted by the side of the road. The bus stopped to allow Erik Hawkins, Co-Facilitator, to take pictures. At 9:40 a.m., the bus arrived at the site of the now closed race course. Committee members left the bus to view the damage caused by illegal racing in the desert. Bob spoke to the committee members and staff on the extent and history of the race course. At 10:02 a.m., committee members reboarded the bus and left to view a tortoise fencing area.

She stated that Sunrise Mountain was designated an ACEC due to its scenic and geologic properties and the presence of rare species. Committee members had questions concerning the status of the bear poppy and the endangered species budget for the area.
