A. Introduction

This appendix provides documentation of the public review process for the Carbon Monoxide Redesignation Request and Maintenance Plan (CO Maintenance Plan). Section B contains the 30-day public comment period newspaper notice. The public comment period ran from May 11th, 2008 to June 10th, 2008. Section C contains affidavits from the Las Vegas Review Journal denoting 3 consecutive publication dates (May 11th, 18th, and 25th).

No official comments were received during the 30-day public comment period. The Environmental Protection Agency provided informal comments after the 30-day public comment period, and the Department of Air Quality and Environmental Management's (DAQEM) response to those comments is included in Section D.

DAQEM brought the plan before the Board of County Commissioners (BCC) on August 19th and requested a public hearing be set for September 2nd, 2008. The Agenda Item to set the public hearing is found in Section E, and the Board Meeting Agenda with open meeting notices and requirements is found in Section F.

On September 2nd, the BCC held a public hearing on the CO Maintenance Plan. The Agenda Item and the Agenda Item Development Report are found in Sections G and H, respectively. The September 2nd Board Meeting Agenda is found in Section I, and denotes open meeting notices and requirements.

There were no public comments at the public hearing. Section J is an attached cassette tape which denotes the official proceedings of the hearing on the CO Maintenance Plan. The documents listed in sections E through J may also be viewed on the web.

There were no formal public comments received on the Carbon Monoxide Redesignation Request and Maintenance Plan during the official comment period. EPA Region IX did provide informal comments after the comment period ended which were incorporated into the plan.

INFORMAL COMMENTS RECEIVED FROM THE EPA AND DAQEM RESPONSE

EPA Region IX comments mainly consisted of correcting typographical errors, deleting unnecessary verbiage, proper referencing, and consistently identifying which emission reduction measures will be used as control measures and which will be used as contingency measures throughout the plan. DAQEM made the requested changes as denoted below.

 EPA commented that Section 5.4, paragraph 1 (p 5-5) says the plan includes only four control measures (the Federal Motor Vehicle Emissions Program, the state I/M Program, a relaxed RVP gasoline standard, and the state Technician Training and Certification Program). The plan actually contains five control measures.

DAQEM response: DAQEM inadvertently excluded the Oxygenated Gasoline Program from said paragraph. The program has since been added as a control measure.

2. EPA commented that Section 6.2.2, paragraph 1 (p 6-2) says:

"The maintenance plan proposes to relax one federally enforceable control measure the reduced RVP gasoline program—and remove three other control measures: the CBG wintertime program, TCM/TDM, and the Alternative Fuels Program. However, the TCM/TDM and the Alternative Fuels Program will be retained in the plan as contingency measures."

The plan is actually discontinuing the CO SIP credits taken from the three previous control measures and retaining all three as contingency measures.

DAQEM response: To correctly denote DAQEMs intent with regards to the three previous control measures, said paragraph was corrected to read:

"The maintenance plan proposes to relax one federally enforceable control measure the Reduced RVP Gasoline Program—and discontinue the CO SIP credits taken from three other previous control measures: the CBG Wintertime Fuels Program, the TCM/TDM Program, and the Alternative Fuels for Government Fleets Program."

3. EPA commented that Section 7.2, Table 7-1 (p 7-2) says the CBG Wintertime Fuels Program is not a contingency measure when, in fact, it is.

DAQEM response: DAQEM incorrectly identified the CBG Wintertime Fuels Program in Table 7-1. The program has since been corrected in Table 7-1 to reflect its status as a contingency measure.

4. EPA commented that Section 7.7, paragraph 1 (p 7-15) refers to CAA 175A for contingency measures. The correct reference should read CAA 175A(d).

DAQEM response: DAQEM corrected the typographical error to now read CAA 175A(d).

5. EPA questioned why Section 2.3 (p 2-2 through 2-3) further analyzed the impact on CO emissions associated with changing the RVP wintertime fuel requirements using a "modified" version of the standard EPA MOBILE6.

DAQEM response: The Section 2.3 analysis contained analyses using both the standard EPA version of MOBILE6 and the modified version of MOBILE6. Since the standard EPA version of MOBILE6 is the only EPA "approved" model for estimating mobile source emissions, DAQEM removed all references to the modified version of the model

6. EPA denoted that the emission reduction measures listed in Section 5.4.2 titled "Other Mobile Source Control Measures" (pp 5-7 through 5-10) be listed separately as contingency control measures, and voluntary and/or state mandated control measures.

DAQEM response: Section 5.4.2 has been re-titled to "Other Carbon Monoxide Control Programs" containing two subsections, (e.g., Section 5.4.2.1 titled "Contingency Measure Programs" and Section 5.4.2.2 titled "State-Mandated and Voluntary Emission Reduction Programs").

7. EPA stated that the analysis contained in Section 6.2.2 (p 6-2) which references CAA 110(I) is somewhat misleading and unnecessary for this section. Specifically, this includes the following language:

"The VMEP guidance limits emission reductions from voluntary programs to 3 percent of that amount needed to attain due to the unenforceable nature of the voluntary measures. However, the state, when including the measures, must still evaluate the programs on an annual basis and commit to replacing the reductions when not being achieved by the measures."

DAQEM response: DAQEM agreed with the EPA that said reference was unnecessary and therefore eliminated the statement from subject section.

8. EPA stated in Section 6.2.2.1 (3), paragraph 2 (p 6-3) that it is unclear how the SIP can include the statement that "... discontinuation of CO SIP credits from the program is not expected to interfere" if there are no estimated benefits from the Alternative Fuels for Government Fleets Program.

DAQEM response: DAQEM clarified the statement to read "discontinuation of CO SIP credits is not expected to interfere since the estimated benefits from this program are small."

9. EPA stated in Section 6.2.2.2, paragraph 2 (p 6-3) that the text indicates that motor vehicle emissions in the PM_{10} plan are insignificant. However, for purposes of conformity, the motor vehicle emission budgets do not address insignificance and the budgets do, in fact, include emissions estimated from motor vehicles, including exhaust.

DAQEM response: DAQEM added EPAs recommended text to include "... so additional reductions were not needed to advance the attainment date."

BACKGROUND:

From the mid-1980s through the 1990s, the Las Vegas Valley exceeded the Carbon Monoxide (CO) National Ambient Air Quality Standards (NAAQS). The U.S. Environmental Protection Agency (EPA) classified the Las Vegas Valley as a "moderate" CO nonattainment area in 1990, and reclassified the valley as a "serious" CO nonattainment area in 1997.

In August 2000, the Clark County Board of County Commissioners (BCC) adopted a state implementation plan (SIP) establishing measures for attaining CO standards. In September 2004, the EPA issued final approval of the August 2000 CO SIP. In October 2005, the BCC adopted a revision to the 2000 CO SIP that updated CO motor vehicle emissions budgets using MOBILE6.2, the latest EPA-approved model for transportation conformity determinations, and the EPA approved the October 2005 SIP revision in August 2006.

EPA determined in June 2005 that the Las Vegas Valley had attained the CO NAAQS by the applicable date of December 31, 2000, making the area eligible to submit a request for redesignation to attainment status for CO. The Carbon Monoxide Redesignation Request and Maintenance Plan is a formal request to the EPA to redesignate the Las Vegas Valley from nonattainment to attainment for the 8-hour CO NAAQS.

The federally required 30-day public comment period was first noticed on May 11, 2008. The 30-day comment period started on Monday, May 12, 2008 and ended on Tuesday, June 10, 2008, at 5:00 p.m. There were no formal public comments received on the plan during the official comment period. EPA Region IX did provide informal comments after the comment period ended which were incorporated into the plan. Staff recommends a public hearing be set on September 2, 2008.

BACKGROUND:

From the mid-1980s through the 1990s, the Las Vegas Valley exceeded the Carbon Monoxide (CO) National Ambient Air Quality Standards (NAAQS). The U.S. Environmental Protection Agency (EPA) classified the Las Vegas Valley as a "moderate" CO nonattainment area in 1990, and reclassified the valley as a "serious" CO nonattainment area in 1997. In August 2000, the Clark County Board of County Commissioners (BCC) adopted a state implementation plan (SIP) establishing measures for attaining CO standards. In September 2004, the EPA issued final approval of the August 2000 CO SIP. In October 2005, the BCC adopted a revision to the 2000 CO SIP that updated CO motor vehicle emissions budgets using MOBILE6.2, the latest EPA-approved model for transportation conformity determinations, and the EPA approved the October 2005 SIP revision in August 2006.

EPA determined in June 2005 that the Las Vegas Valley had attained the CO NAAQS by the applicable date of December 31, 2000, making the area eligible to submit a request for redesignation to attainment status for CO. The attached Carbon Monoxide Redesignation Request and Maintenance Plan is a formal request to the EPA to redesignate the Las Vegas Valley from nonattainment to attainment for the 8-hour CO NAAQS. See the attached Agenda Item Development Report No. 3176 for additional information.

The federally required 30-day public comment period was first noticed on May 11, 2008. It began on May 12, 2008 and ended on June 10, 2008. There were no formal public comments received on the plan during the official comment period. EPA Region IX did provide informal comments after the comment period ended which were incorporated into the plan. Staff recommends that the Board approve the Plan and authorize staff to submit it to the State and EPA for final approval.

Subject/Title:

Carbon Monoxide Redesignation Request and Maintenance Plan

Recommended Action:

That the Board of County Commissioners conduct a Public Hearing and approve the Carbon Monoxide Redesignation Request and Maintenance Plan by Resolution for submittal to the State and US EPA for their review and approval as a State Implementation Plan revision.

Summary:

The Clark County Department of Air Quality and Environmental Management (DAQEM) prepared the 2008 Carbon Monoxide Redesignation Request and Maintenance Plan (2008 Plan) as a formal request to the U.S. Environmental Protection Agency (EPA) to redesignate the Las Vegas Valley Nonattainment Area to attainment status for the National Ambient Air Quality Standards (NAAQS) for carbon monoxide (CO).

In the mid-1980s, the Las Vegas Valley exceeded the CO NAAQS during the winter. In 1990, EPA classified the valley as a "moderate" CO nonattainment area and, in 1997, reclassified the valley as a "serious" CO nonattainment area. EPA approved a 2000 Clark County CO State Implementation Plan (SIP) in 2004, and approved a 2005 CO SIP Revision in 2006.

Over the last ten years, the Las Vegas Valley has experienced substantial improvement in air quality; no violations of the 8-hour CO standard have been recorded since 1998. There has also been a reduction in the intensity of CO concentrations. In June 2005, EPA found that the Las Vegas Valley had attained the CO NAAQS by the applicable date of December 31, 2000, making the area eligible to submit a request for redesignation to attainment status for CO.

Analyses in the 2008 Plan show that measured ambient air quality has attained the CO NAAQS, and the emission reductions responsible for the air quality improvement are both permanent and enforceable. The 2008 Plan includes modifications to current CO control measures and

updated motor vehicle emissions budgets for making future conformity determinations. Also, the 2008 Plan demonstrates maintenance of the CO NAAQS through 2020 with modifications to the committed control measures contained in the 2000 CO SIP and 2005 CO SIP Revision.

The primary state and county control measures that led to achieving attainment for CO, include: (1) the state of Nevada's motor vehicle I/M program (adopted 1978); (2) the oxygenated gasoline program (adopted 1991/1995); (3) reduced Reid Vapor Pressure (RVP) gasoline program (adopted 1995); and (4) the cleaner burning gasoline wintertime program (adopted 1999). In addition, CO emissions from point sources, which account for 3 percent of CO emissions, were reduced by New Source Review and SIP approved permitting rules.

To ensure CO attainment through 2020, the 2008 Plan relies, without modification, on a number of primary control measures initially employed by the 2000 CO SIP and 2005 CO SIP Revision, including the state of Nevada's motor vehicle I/M program and the oxygenated gasoline program. The 2008 Plan does not suggest any other control measurers for stationary point or area sources, other than the minimum requirements.

The I/M program will continue to serve as a primary control measure for achieving continued attainment for CO through 2020, as it is recognized that emission reductions since the I/M program's inception have been central to decreasing CO concentrations. This program was initially adopted by the state in 1978 and is administered by the Department of Motor Vehicles. The program requires that all 1968 or newer gasoline-powered vehicles, regardless of size, and all diesel vehicles, up to 10,000 pounds, pass an annual test. This program also serves to reduce other pollutants, such as ozone.

Likewise, the oxygenated gasoline program, which requires that all fuel during the winter season (October 1 to March 31) contain 3.5 percent oxygenate by weight, will also continue to serve as a primary control measure for reducing CO emissions. It is recognized that this program helped to significantly reduce CO emissions during the wintertime, primarily because the standard was more stringent than the original national requirement (which was denoted in the 1990 Clean Air Act Amendments as requiring all fuel in the winter season to contain 2.7 percent oxygenate by weight). This program is strongly supported by industry and aids sustainability, thereby reducing reliance on petroleum based fuel.

The 2008 Plan also utilizes a reduced RVP gasoline program. This modified program will have a positive impact on gasoline supplies to the Las Vegas Valley because it will no longer preclude the distribution/sale of conventional and reformulated gasoline, which is sold all over the southwestern United States during the winter season.

The Las Vegas Valley also benefits from other CO control measures. These programs are not used for numeric emission reduction credit for the CO maintenance plan, but do play an important role in assisting in reducing CO emissions. These programs include: (1) Voluntary Transportation Control Measures (TCM) / Transportation Demand Management (TDM), such as

the Club Ride commuter program; (2) alternative fuel programs; (3) heavy-duty vehicle program; (4) smoking vehicle program; (5) voluntary vehicle repair program; (6) advanced truck stop electrification program; (7) federal fleet program; (8) diesel engine retrofit program; and (9) the Clark County School District Bus Retrofit Program.

The 2008 Plan relies heavily on previously EPA-approved SIPs and their technical support documents. The primary control measures identified in the 2008 Plan provides Clark County with measures designed to prevent and/or remedy future CO NAAQS violations. Once the 2008 Plan is approved by EPA, it will become the federally-enforceable plan that identifies how Clark County will maintain the CO NAAQS for the Las Vegas Valley through 2020.

BACKGROUND:

From the mid-1980s through the 1990s, the Las Vegas Valley exceeded the Carbon Monoxide (CO) National Ambient Air Quality Standards (NAAQS). The U.S. Environmental Protection Agency (EPA) classified the Las Vegas Valley as a "moderate" CO nonattainment area in 1990, and reclassified the valley as a "serious" CO nonattainment area in 1997. In August 2000, the Clark County Board of County Commissioners (BCC) adopted a state implementation plan (SIP) establishing measures for attaining CO standards. In September 2004, the EPA issued final approval of the August 2000 CO SIP. In October 2005, the BCC adopted a revision to the 2000 CO SIP that updated CO motor vehicle emissions budgets using MOBILE6.2, the latest EPA-approved model for transportation conformity determinations, and the EPA approved the October 2005 SIP revision in August 2006.

EPA determined in June 2005 that the Las Vegas Valley had attained the CO NAAQS by the applicable date of December 31, 2000, making the area eligible to submit a request for redesignation to attainment status for CO. The attached Carbon Monoxide Redesignation Request and Maintenance Plan is a formal request to the EPA to redesignate the Las Vegas Valley from nonattainment to attainment for the 8-hour CO NAAQS. See the attached Agenda Item Development Report No. 3176 for additional information.

The federally required 30-day public comment period was first noticed on May 11, 2008. It began on May 12, 2008 and ended on June 10, 2008. There were no formal public comments received on the plan during the official comment period. EPA Region IX did provide informal comments after the comment period ended which were incorporated into the plan. Staff recommends that the Board approve the Plan and authorize staff to submit it to the State and EPA for final approval.

RESOLUTION OF THE CLARK COUNTY BOARD OF COMMISSIONERS ADOPTING THE CLARK COUNTY CARBON MONOXIDE REDESIGNATION REQUEST AND MAINTENANCE PLAN

WHEREAS, from the mid-1980s through the 1990s, the Las Vegas Valley exceeded the Carbon Monoxide (CO) National Ambient Air Quality Standards (NAAQS); and

WHEREAS, the Las Vegas Valley was classified as a "moderate" CO nonattainment area in 1990, and reclassified as a "serious" nonattainment area in 1997, for not meeting the NAAQS by the United States Environmental Protection Agency (EPA) under the federal Clean Air Act (CAA); and

WHEREAS, the CAA, as amended in 1990, requires states having nonattainment areas within their jurisdiction to develop procedures and criteria for attaining the NAAQS via a State Implementation Plan (SIP); and

WHEREAS, pursuant to the CAA and under the authority of NRS 445B.500, the Clark County Board of County Commissioners is designated as the air pollution control agency for the purposes of NRS 445B.100 to NRS 445.640, inclusive; and

WHEREAS, the Clark County Board of County Commissioners adopted a SIP establishing measures for attaining CO standards in August 2000; and

WHEREAS, the EPA issued final approval of the August 2000 CO SIP in September 2004; and

WHEREAS, the Clark County Board of County Commissioners adopted a revision to the 2000 CO SIP that updated CO motor vehicle emissions budgets using MOBILE6.2, the latest EPA-approved model for transportation conformity determinations, in October 2005; and

WHEREAS, the EPA issued final approval of October 2005 SIP revision in August 2006; and

WHEREAS, the EPA determined in June 2005 that the Las Vegas Valley had attained the CO NAAQS by the applicable date of December 31, 2000 making the area eligible to submit a request for redesignation to attainment status for CO; and

WHEREAS, the Department of Air Quality and Environmental Management (DAQEM) has been designated by the Clark County Board of County Commissioners as the air pollution control agency for Clark County; and

WHEREAS, the DAQEM developed the Clark County Carbon Monoxide Redesignation Request and Maintenance Plan to serve as a formal request to the EPA to redesignate the Las Vegas Valley from nonattainment to attainment for the 8-hour CO NAAQS; and WHEREAS, the Clark County Board of County Commissioners is required upon adoption to submit the Clark County Carbon Monoxide Redesignation Request and Maintenance Plan to the state of Nevada and EPA for their approval and incorporation into the SIP.

NOW, THEREFORE, BE IT RESOLVED by the Clark County Board of County Commissioners:

That the Clark County Board of County Commissioners adopts the Clark County Carbon Monoxide Redesignation Request and Maintenance Plan.
