VI. Receive the Director's Report on the Activities of the Department of Juvenile Justice Services a. Budget/Personnel Update

- **i.** Our second Assistant Director position will be filled by Eboni Washington beginning on April 8th. Eboni comes from the Department of Family Services where she also served as an assistant director. She brings a wealth of experience in many areas but one we are especially excited about is her background with grants. She will directly supervise our Financial Services and Health Care Services divisions.
- **ii.** Our JPO II Academy will graduate April 19th, at 10am at our Pearson Community Center, 1625 W. Carey Ave.
- **iii.** DJJS has extended gap payments to specialized foster care to supplement the Medicaid rate reduction.
- b. **Legislature** Below are some of the current bills we are monitoring. Sponsors and co-sponsors for each bill are listed on the first page of PDF's attached to email.
 - **i.** AB168-Revises provisions governing the discipline of pupils. Requires a school to provide a plan of action based on restorative justice before suspending or expelling a student.
 - ii. AB322-Establishes provisions relating to juvenile assessment center.
 - **iii.** AB350-Revises provisions relating to higher education.
 - **iv.** AB449-Directs the Legislative Committee on Child Welfare and Juvenile Justice to conduct a study relating to juvenile detention in this State.
 - v. SB242-Revises provisions relating to peace officers.
 - vi. SB247-Requires informed consent of a parent or guardian before certain services related to mental health are provided to a child.
 - vii. SB317-Establishes provisions relating to juvenile assessment centers.
- **c.** Juvenile Detention Reform Mr. Martin continues to work with Workforce Connections with connecting youth to meaningful employment, vocational programs, wrap around services, dual credit opportunities, etc.

d. Juvenile Justice Programming

- **i.** Caseload Pro will go live August or September. We are excited for the quality assurance aspect of the system and different tracking and statistical reports that will be available once data is being entered.
- **ii.** Youth will be moving into the new Spring Mountain Residential Center any day! Mr. Martin still intends to rebuild the previous home for girls. He has identified funding to pursue for this project.

e. The Harbor Update

- **i.** More than 7,300 youth and their families have been served at our Harbor locations with still only a 5% recidivism rate.
- **ii.** The Harbor won the Good Governance Award for 2019 and was part of the All-America City dignitary award for 2018.

 - **i.** Dr. Villalobos is the chairman for the newly awarded DOL CPLC (Chicanos Por La Causa) YouthBuild advisory council. Recruitment for youth will begin in the next couple months. The program assists youth 18-24 years of age.
 - **ii.** Dr. Villalobos also shared that the City of Las Vegas Ward 5 has partnered with the CSN to start a new construction program. Primary target population is Ward 5 but is open to the public. The program will offer nationally recognized construction credential which is portable across the country.
