a. Budget/Personnel Update

-Our budget meeting May 16 will determine if we receive any of the positions we requested for next fiscal year.

-There is currently 8 staff in the Academy, two are from Youth Parole. -Mr. Martin is working with Clinical Services on a medical contract to acquire a quality provider, expand available resources, and to increase hours of coverage.

b. Legislature

-District Attorney Brigid Duffy is researching Colorado's Juvenile Assessment Center Bill SB 94 for future legislation to model successful pieces of it within our agency. This will help solidify requirements and restrictions on detention population, state funding, and create predictability on detention numbers. -Mr. Martin received news that the SAPTA grant is approved and the agency is now working on proposals. We are still waiting to hear the outcome for the VOCA grant.

- c. Juvenile Detention Reform Nothing new at this time
- **d.** Juvenile Justice Programming Caseload Pro (Family Tracs 2.0) is progressing and will be able to provide immediate stats, real time data and tracking, and will increase our ability to monitor probationers. Tentative start date is Oct. 2016.

e. Assessment Center Update – The inter local agreement has been drafted and sent to all governmental partners. We are waiting for feedback. Next step is meeting with providers and preparing resources. The assessment center will be under the Clinical Services Division and run by Cesar Lemos.
