## a. Budget/Personnel Update

- **i.** We have asked for additional staff in order to expand the evening reporting center to increase community based services.
- ii. Budget remains flat.
- iii. Next JPO Academy is scheduled to begin July 17, 2017.
- **b.** Legislature Legislation session ended June 5, 2017. Mr. Martin stated that a number of bills that will be helpful to juvenile justice passed. Overall it was a very busy session.
- c. Juvenile Detention Reform
  - i. **Temporary Kitchen** Detention will have a temporary kitchen for about three months due to the new sewer project.
- d. Juvenile Justice Programming  $N\!/\!A$
- e. The Harbor Update
  - **i.** The Harbor has serviced approximately 1400 youth to date. Less than four percent have escalated into the juvenile justice system.

- **ii.** The department is looking to expand The Harbor hours in the future. Currently we are open Monday-Friday 8am to midnight.
- **iii.** There are now classes available to help youth and families at The Harbor.
- f. DJJS Strategic Plans Update
  - i. Mr. Martin briefly went over DJJS strategic plans. Mr. Martin also discussed long term objective of building a new detention facility for youth. The current facility is outdated and has a number of safety and security issues.
  - **ii.** Succession Plan DJJS is making succession planning and leadership development a part of our culture.
  - **iii.** New Eastside Probation Location Targeted Case Management funding will go to pay for the new Eastside Probation location.
