# XII. Public Comments

• A field trip will be conducted during the December 7, 2011 Citizens Advisory Committee meeting scheduled at 9 AM. Mr. Reese will take the committee members on a tour of Intake/Booking.

- Attorney Mari Parlade is with the Diversion Program (Truancy Court). She stated that the District Attorney's Office had a lack of resources when filing youth petitions; therefore truancy court was disseminated. Mari indicated there was a 69% turnaround period with the Truancy Court, which was good. The youth's grades and truancy situation were looked at and monitored. Truancy Court was successful because many services were wrapped into the program. The Truancy Diversion Program is not as successful as Truancy Court because it is on a volunteer basis. The youth are not giving the slips to the parents. The Diversion Program is in fourteen schools. The participation from the parents is needed. Mari would like the Citizens Advisory Committee to keep this in mind during the 2012 legislation. Perhaps a bill draft can be presented on behalf of the Diversion Program.
- Judges approved \$1,000 for the Detention Library.
- The <u>*Thinking For a Change*</u> training was held October 22<sup>nd</sup> through October 25, 2011 and it went well. This is a thirty-two credit hour training. Richard Robinson will be the Facilitator for the training.
- Judge Voy stated that the <u>"Changing Our Youths in America (COYA)</u> Program was approved for \$432 per kid for twelve weeks at SMYC. The Judge stated this is an excellent program for the youth. COYA is a nonprofit program providing intervention, services and mentor programs for middle and high school youth in the Clark County area. The program will form partnerships with local school districts, juvenile justice service entities and the juvenile court system.
- Judge Voy stated that monies were approved for the revised Ropes Course.
- Judge Voy, Fritz Reese, Jack Martin, and Tim Moody from Metro had a meeting to do a Memorandum of Understanding (MOU). The MOU is to have Metro Police Officers to partner with DJJS Officers while they are out in the field when working with youth.
- Jack Martin Stated that he went to the HUD / Sherman Gardens Project meeting. Jack indicated it was a positive turn out. Some members from this meeting will be helping the Mack Kelly School Administration to work with the youth that may have some behavioral issues.
