The Citizens Advisory Committee made a motion to send their resolution to Governor Sandoval and Legislators. The letter will state that The Clark County Department of Juvenile Justice Services Citizen's Advisory Committee respectfully opposes the cuts in Health and Human Services budget that severely reduces funding to local Juvenile Justice Departments throughout the state and especially Clark County. Of particular concern is the cost of Youth Parole to be billed back to the counties. Fritz will draft a letter.
