### After-School / Open Recreation Program

This program provides fun and supervised recreational activities for youth ages 6 - 17 years old free of charge. 18 year olds can attend this program if he/she is still attending high school. Prior to attending, a parent or legal guardian must complete an enrollment form for his /her child.

Identification card will be provided for each After-School/Open Recreation participant. Identification cards for ages 6 - 11 will be placed on file at the Walnut Recreation Center. Ages 12 - 17 must bring his/her identification card each day and swipe in. If participant does not bring his/her card, he/she will not be allowed to participate in the After-School/ Open Recreation Program. To receive an identification card all participants' ages 12 - 17must show proof of age by providing current school i.d., valid Nevada Identification Card, or a parent/guardian must sign up youth participant in person at the front desk. Identification cards are free. A \$2.00 fee will be charged for replacement/lost cards.

### TO PARTICIPATE IN PROGRAM

- 1. All participants must present a valid Walnut Recreation Center After school card.
- 2. There will be no weapons allowed in the Walnut Recreation Center, except by authorized personnel (i.e. On-Duty Police).
- 3. No loitering in the halls or bathrooms.
- 4. No children under the age of six will be allowed in the program.
- 5. Promotes high standard of ethics, on sportsmanship and personal conduct.
- 6. Food and beverages (except water) will not be allowed in the program.
- 7. Smoking in the facility is not allowed.
- 8. Chewing gum while in the gym is not allowed. Spitting on facility floors or walls is not allowed.
- 9. Fighting, profanity and/ or abusive language is not allowed on county property.
- 10. Any form of intimidation directed at participants, observers, or Walnut staff members will no be tolerated.
- 11. No wearing of baseball caps, do rags or other headgear.
- 12. Any misuse or abuse of the equipment may require restitution.
- 13. Appropriate clothing and athletic-style shoes are required (*No sandals or flip-flops allowed*). Undergarments must not be exposed.
- 14. After School program will practice positive/progressive discipline:
  - □ Step one- Warning
  - □ Step two- Write up
  - □ Step three- Suspension
  - □ If behavior persists the participant will be suspended indefinitely.

#### (Please read and sign other side)

Our number one goal is for all the participants to be safe and have fun! Staff will take the following positive and progressive discipline steps to get a child back on track when addressing discipline matters: Participant will be separated from the group and explain why the behavior is inappropriate. Inform the participant what they need to do to correct the problem. Explain the consequences if the problem persists. Actions that are more serious in nature such as fighting, stealing or repeated behavioral problems may result in suspension from the After School/Open Recreation Program. Suspension from the After School /Open Recreation Program requires participants to leave the facility for the duration of the suspension.

I hereby agree to ALL terms of this code of conduct and understand the consequences for my action. I also understand that I must follow all recreation center guidelines to be in accordance with Walnut Recreation Center policy and procedures.
