- 5. Budget Presentations (not an action item).
 - a. Silver Bowl Iconic Soccer Themed Sculpture Proposal is to create a soccer themed sculpture no less than 30 feet in the air to replace the iconic Yesco soccer ball. Existing art and column will be demolished due to the structural issues. Proposed budget of YTBD.

Due to unsafe structure, the sculpture needs to be removed. Clark County wants to create something else iconic to replace it. The committee deemed it worthwhile for staff to continue to pursue a replacement for the sculpture with a budget of \$500,000. A possible vote will be conducted in April when budgets are presented to the committee.

- 6. Discussion on an Unincorporated Clark County comprehensive detailed Arts and Culture Plan. This would be a community-wide plan based on broadly defined understanding of culture with integrated goals compiled through community consultation (*not an action item*). The committee engaged in discussion of different types of cultural plans and are leaning towards a comprehensive detail cultural plan. If a plan is approved, staff recommends forming an advisory committee that reflects the art community in all aspects. This subcommittee would develop goals for the RFP for an Arts and Cultural Master Plan.
