- a. Youth Villages for Step Up has expanded; two new case managers who meet with young adults weekly along with a licensed clinician.
- b. Three new Step Up workers: Cedric Starling, Lisa Lamb, and Julia Haro.
  - i. One more new hire starting in a couple of weeks
  - ii. Step Up is looking for a new Office Assistant.
- c. Current Step Up young adults very high; highest number of young adults since 2015

- a. Dress for Success
  - i. Provides services for women to reduce poverty and help with economic independence.
  - ii. Provides interview attire and helps with employment attire.
  - iii. Age 16+, with no age limit or income qualifier.
  - iv. Self-referrals are accepted.
- b. Film Allegiance (Emilio Swann and Fernando)
  - i. New 503(c) nonprofit (film agency)
    - 1. Provides youth a chance for dreams and passions
    - 2. Ages 12-18
      - a. Offers tools, connections, and networking with people in the film industry.
- c. Movement Fitness Sports (Lelan Sparks)
  - i. Provides all types of activities, from small to large sporting events.
  - ii. Focuses on youth development and behavior management.
- d. Children's Foundation of Las Vegas (B'Anka Neder)
  - i. New name for the same organization (formerly CASA Foundation)

- 1. Over 40 years of service.
- ii. Assists with tutoring, sports, extracurriculars, dental, medical devices, and more.
- iii. Provides for the needs of foster care and is a resource and support for all of Clark County.
- e. Shining Star (Sabrina)
  - i. Shining Star classes are ongoing at Child Have for youth on campus.
  - ii. Has the capacity for DJJS classes.
  - iii. Works with St. Jude's and DJJS
  - iv. Serves 100+ youth per year.
  - v. New grant received (Clinical Client Coordination Grant)
- f. Fostering Seeds of Hope (Crystal Patterson)
  - i. Helps with supplies, such as cleaning supplies, moving supplies, gas, Christmas gifts, breast pumps, family dinners, and more
    - 1. For aged out foster youth. No age limit.
    - 2. Serves youth also in rural areas.
- g. RISE Homes (Deja)
  - i. Offers shared housing
  - ii. Residents are offered job placement, haircuts, and food delivery.
  - iii. First grant has been approved (self-funded prior)
    - 1. Grant will be used to focus on transitioning from shared housing to permanent placement.
- h. DFS (Allyson M)
  - i. There will be a foster resource fair on March 26, 2022.
  - ii. Walk-ins are allowed.
  - iii. Employers will be present to hire teens for summer jobs.
- i. NSHE (Laura Obrist)
  - i. NSHE has received new grants
    - 1. New position at UNR, similar to Heather Richardson at UNLV (Fostering Scholars Program).
      - a. New program will be called "Fostering the Pack"
    - 2. Truckee Meadows will also start a new program, similar to UNR, called "Fostering College Success Program.
  - ii. For all non-UNLV questions, please direct them to Laura Obrist or the school, rather than Heather Richardson.
- j. Legal Aid (Jaymie Junsay)
  - i. RISE app promotion (RISE app is a resource app for youth and young adults that can be downloaded from Google Play and the App Store).
